traditional straight anastomosis for low rectal cancer. The findings are interesting and it is a well written paper. However, this study is a single center study with a small sample. The authors should point out the limitations of this study in the discussion section and the conclusion should be downgraded. The questions raised by the reviewers should be answered; and (3) Format: There are 4 tables and 4 figures. A total of 25 references are cited, including 6 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B, Grade B, Grade B and Grade A. A language editing certificate issued by Medjaden was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, and the Institutional Review Board Approval Form. Written informed consent was waived. The authors need to provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by Chongqing Key Diseases Research and Application Demonstration Program. The topic has not previously been published in the WJGS. The corresponding author has 1 published article in the BPG. 5 Issues raised: (1) I found the authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); (2) I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange

	<p>the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (3) the author should number the references in Arabic numerals according to the citation order in the text. The reference numbers will be superscripted in square brackets at the end of the sentence with the citation content or after the cited author's name, with no spaces; and (4) for statistical significance, please use superscript letters.
