2	<p><i>Editorial Office's Comments</i></p> <p>Science Editor: 1 Scientific quality: The manuscript describes a meta-analysis of the T-tube in orthotopic liver transplantation. The topic is within the scope of the WJG. (1) Classification: Grade B, Grade C, and Grade C; (2) Summary of the Peer-Review Report:</p>	[Y]

This systematic review and meta-analysis aimed at evaluating the safety and effectiveness of T-tube placement after biliary reconstruction in the liver transplant setting. Given the heterogeneity among studies and across results provided by this meta-analysis, I suggest to modify the conclusion section in the Abstract body. Indeed, in my opinion, results are not strong enough to suggest against the use of T tube; and (3) Format: There are 4 tables and 5 figures. A total of 47 references are cited, including 9 references published in the last 3 years. There are no self-citations.

2 Language evaluation: Classification: Grade B, Grade B, and Grade C. A language editing certificate issued by AJE was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate and PRISMA 2009 Checklist. Please provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by National Natural Science Foundation of China and Innovation Capacity Support Plan of Shaanxi Province. The topic has not previously been published in the WJG.
