(1) Classification: Grade B; (2) Summary of the Peer-Review Report: This narrative review study highlights the knowledge-gaps and sets a foundation for the required explanatory control mechanisms that evolve and expand a more detailed multi-dimensional slacklining model and human functional movement. written; and (3) Format: There are no tables or figures. A total of 114 references are cited, including 14 references published in the last 3 years. There are 7 self-citations. 2 Language evaluation: Classification: Grade B. 3 Academic norms and rules: The authors need to provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an invited manuscript. The topic has not previously been published in the WJO. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) I found the authors did not add the PMID and DOI in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout; and (2) There are 7 self-citations. The manuscript could only have 3 self-citations according to the editorial policy of BPG. Please check and revise. 6 Re-Review: Not required. 7 Recommendation: Conditionally accepted.
