Sep 13, 2017 · 5G leads to massive increase of mandatory exposure to **wireless radiation** . 5G technology is effective only over short distance. It is poorly transmitted through solid material. Many new antennas will be required and full-scale implementation will result in antennas every 10 to 12 houses in urban areas, thus massively increasing mandatory exposure.
