They have done a very thorough job on hepatitis C virus infection. However, the language of the manuscript needs further polishing; and (3) Format:</p>	[Y]

There is 1 table. A total of 115 references are cited, including 77 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B. 3 Academic norms and rules: The authors need to provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an invited manuscript. The topic has not previously been published in the WJG. 5 Issues raised: (1) The authors' information should be added in the first page of the manuscript; (2) The "Author Contributions" section is missing. Please provide the author contributions; (3) PMID and DOI numbers are missing in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout; and (4) The references' number cited in the text should be put in the square bracket. 6 Re-Review: Not required. 7 Recommendation: Conditional acceptance.
