The topic is within the scope of the WJGO. (1) Classification: Grade A; (2) Summary of the Peer-Review Report: The authors reported a well written retrospective study looking at molecular expression between</p>	[Y]

primary gastric cancer and remnant gastric cancer occurring a minimum of 5 years after original resection in the case of resection for malignancy and any time after resection for benign disease. However, some questions raised by the reviewer should be answered; and (3) Format: There are 2 tables and 3 figures. A total of 41 references are cited, including 13 references published in the last 3 years. There are 9 self-citations, which are related to this study. 2 Language evaluation: Classification: Grade A. A language editing certificate issued by AJE was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, and the Institutional Review Board Approval Form. The authors need to provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, and written informed consent signed by the patients. No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an invited manuscript. The study was supported by 1 grant. The topic has not previously been published in the WJGO. 5 Issues raised: (1) The authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); (2) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (3) The "Article Highlights" section is missing. Please add the "Article Highlights" section at the end of the main text; and (4)
