new strategy of a triple route of administration. The results in term of safety are good as well preliminary efficacy but with a small population with a wide age range. The questions raised by the reviewers should be answered; and (3) Format: There are 8 tables and 2 figures. A total of 35 references are cited, including 9 references published in the last 3 years. There are 2 self-citations (Ref. 6, 7). The topics of the self-citations are related to this study. 2 Language evaluation: Classification: Grade B. A language editing certificate issued by Protranslate was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the Institutional Review Board Approval Form, and the Written informed consent. No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an invited manuscript. No financial support was obtained for the study. The topic has not previously been published in the WJT. 5 Issues raised: (1) The key word "transplantation" is missing in the title. Please add it; (2) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (3) The "Article Highlights" section is missing. Please add the "Article Highlights" section at the end of the main text; and (4) Authors should always cite references that are relevant to their study. Please check and remove any references that not relevant to this study. 6 Recommendation: Conditional acceptance.
