The topic is within the scope of the WJG. (1) Classification: Grade B and Grade C; (2) Summary of the Peer-Review Report: The authors reported a nice and well written audit from the endoscopy unit. The topic is current and the paper is good. However, some references should be added. The</p>	[Y]

questions raised by the reviewers should be answered; and (3) Format: There are 2 tables and 3 figures. A total of 27 references are cited, including 27 references published in the last 3 years. There are 2 self-citations. 2 Language evaluation: Classification: Grade B and Grade B. A language editing certificate issued by NURISCO was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, and the Institutional Review Board Approval Form. Written informed consent was waived. The authors need to provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The topic has not previously been published in the WJG. 5 Issues raised: (1) The "Author Contributions" section is missing. Please provide the author contributions; (2) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (3) The "Article Highlights" section is missing. Please add the "Article Highlights" section at the end of the main text; and (4) Authors should always cite references that are relevant to their study. Please check and remove any references that not relevant to this study. Authors should not cite their own unrelated published articles. Please check and remove any references not relevant to this study. The authors self-referencing number should be no more than 3. 6
