The topic is within the scope of the WJGS. (1) Classification: Grade B, Grade C, Grade C and Grade D; (2) Summary of the Peer-Review Report: Overall, it is a good article, well-structured and easy to read. Mechanism of potential impact of coronavirus on pancreatic cells are described in detail. Please state the prognosis of patients</p>	[Y]

with AP in COVID-19. The questions raised by the reviewers should be answered; and (3) Format: There are 4 tables and 4 figures. A total of 42 references are cited, including 33 references published in the 2020. There are no self-citations. 2 Language evaluation: Classification: Grade A, Grade B, Grade B and Grade B. 3 Academic norms and rules: The authors need to provide the Biostatistics Review Certificate, the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, and the PRISMA checklist. No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an invited manuscript. The topic has not previously been published in the WJGS. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) I found no "Author contribution" section. Please provide the author contributions; (2) I found the authors did not add the PMID and DOI in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout; (3) I found the authors did not write the "article highlight" section. Please write the "article highlights" section at the end of the main text; (4) I have changed the manuscript type "review" to "systematic review". Please revise the manuscript according to the Guidelines and Requirements for "systematic review"; and (5) the author should number the references in Arabic numerals according to the citation order in the text. The reference numbers will be superscripted in square brackets at the end of the sentence with the
