The topic is within the scope of the WJG. (1) Classification: Grade B; (2) Summary of the Peer-Review Report: The authors describe systematically the relationship between obesity and MAFLD and COVID-19, describe the preexisting patients who are more likely to be hospitalized as a result of CAVD-19 and describe possible</p>	[Y]

mechanisms between the two diseases. The manuscript has a good quality. However, it is suggested to add more figures to make the article more interesting. The questions raised by the reviewers should be answered; and (3) Format: There is 1 figure. A total of 83 references are cited, including 46 references published in the 2020. There is 1 self-citation. This cited article is relevant to this study. 2 Language evaluation: Classification: Grade A. 3 Academic norms and rules: The authors need to provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an invited manuscript. The study was supported by Conselho Nacional de Desenvolvimento Científico e Tecnológico; and Fundação de Amparo à Pesquisa do Estado Rio de Janeiro, FAPERJ. The topic has not previously been published in the WJG. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) I found the authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); and (2) I found the authors did not provide the original figures. Please provide the original figure documents.
