The topic is within the scope of the WJCO. (1) Classification: Grade C; (2) Summary of the Peer-Review Report: The authors report that T RM cells exist in MSS, MSI-H BRAF mut and MSI-H BRAF wt CRC. MSS CRC. This manuscript is well written. While interesting, the manuscript has number of small shortcomings. The questions raised by the reviewers should be answered; and (3) Format: There are 5 tables and 5 figures. A total of 53 references are cited, including 26 references published in the last 3 years. There is 1 self-citation (Ref. 20). The topic of the self-citation is related to this study. 2 Language evaluation: Classification: Grade C. No language editing certificate was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the Institutional Review Board Approval Form and the written informed consent was not provided. No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an invited manuscript. No financial support was obtained for the study. The topic has not previously been published in the WJCO. 5 Issues raised: (1) The language classification is Grade C.
