capable of specific detection of the ABI1-SiL isoform. Authors are commended for their extensive and well carried out study and offering a putative biomarker and novel therapeutic target for colon cancer. The questions raised by the reviewers should be answered; and (3) Format: There are 9 figures. A total of 37 references are cited, including no references published in the last 3 years. There are 2 self-citations (Ref. 16, 26). The topics of the self-citations are related to this study. 2 Language evaluation: Classification: Grade A and two Grades B. A language editing certificate issued by BioMed Proofreading was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, and the Institutional Review Board Approval Form. No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by The National Natural Science Foundation of China, The Peking University People's Hospital Scientific Research Development Found. The topic has not previously been published in the WJG. 5 Issues raised: (1) The authors did not provide the approved grant application form(s). Please provide the original figure documents.
