(1) Classification: Grade B and Grade B; (2) Summary of the Peer-Review Report: This review talks about current status of diagnosis and therapy for intraductal papillary neoplasm of the bile duct. summary of this article has good clinical reference value. However, the paper needs some minor language polishing to render it easier to read. The questions raised by the reviewers should be answered; and (3) Format: There are 6 figures. A total of 35 references are cited, without references published in the last 3 years. There are 6 self-citations. These cited articles are all relevant to this study. 2 Language evaluation: Classification: Grade A and Grade B. A language editing certificate was provided. 3 Academic norms and rules: The authors need to provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an invited manuscript. The topic has not previously been published in the WJG. The corresponding author has published 2 articles in the BPG. 5 Issues raised: (1) I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (2) Please obtain permission for the use of picture(s). If an author of a submission is re-using a figure or figures published elsewhere, or that is copyrighted, the author must provide documentation that the previous publisher or copyright holder has given permission for the figure to be re-published; and correctly indicating the reference source and copyrights. For example, "Figure 1 Histopathological examination by hematoxylin-eosin staining (200 ×). A: Control

group; B: Model group; C: Pioglitazone hydrochloride group; D: Chinese herbal medicine group.
