The topic is within the scope of the WJG. (1) Classification: Grade A, two Grades B, and Grade C; (2) Summary of the Peer-Review Report: The overall structure of the manuscript is complete. The text and figures are well structured</p>	[Y]

and the methods employed are logical and well described. In regard to the ethical considerations, the text appears to be appropriate. The questions raised by the reviewers should be answered; and (3) Format: There is 1 table and 8 figures. A total of 87 references are cited, including 35 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade A and three Grades B. A language editing certificate issued by Charlesworth was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the Institutional Review Board Approval Form, and the written informed consent. No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an invited manuscript. The study was supported by National Natural Science Foundation of China. The topic has not previously been published in the WJG. 5 Issues raised: (1) The key word “gut” is missing in the title. Please add it; (2) The authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); (3) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (4) The “Article Highlights” section is missing. Please add the “Article Highlights” section at the end of the main text; and (5) Authors should always cite references that are relevant to their study. Please check and
