2	<p><i>Editorial Office's Comments</i></p> <p>Science Editor: 1 Scientific quality: The manuscript describes an evidence review of the role of microbial dysbiosis in the pathogenesis of esophageal mucosal disease. The topic is within the scope of the WJG. (1) Classification: Two Grades B; (2) Summary of the Peer-Review Report: This is a review article discussing the pathogenesis of oesophageal diseases from the perspective of microbial dysbiosis, with an interesting title and good coverage.</p>	[Y]

The title of the article is interesting and well-written. The questions raised by the reviewers should be answered; (3) Format: There is 1 table and 1 figure; (4) References: A total of 135 references are cited, including 45 references published in the last 3 years; (5) Self-cited references: There are 2 self-cited references. The self-referencing rates should be less than 10%. Please keep the reasonable self-citations (i.e. those that are most closely related to the topic of the manuscript) and remove all other improper self-citations. If the authors fail to address the critical issue of self-citation, the editing process of this manuscript will be terminated; and (6) References recommendations: The authors have the right to refuse to cite improper references recommended by the peer reviewer(s), especially references published by the peer reviewer(s) him/herself (themselves). Please provide the PubMed numbers to the reference list and list all authors of the references. Please revise throughout; and (4) If an author of a submission is re-using a figure or figures published elsewhere, or that is copyrighted, the author must provide documentation that the previous publisher or copyright holder has given permission for the figure to be re-published; and correctly indicating the reference source and copyrights.
