The topic is within the scope of the WJGS. (1) Classification: Grade C, Grade C, Grade D and Grade D; (2) Summary of the Peer-Review Report: The authors reported an interesting review about the association of Corona Virus-19</p>	[Y]

infection and clinical development of acute pancreatitis. However, the literature study is too primary. The questions raised by the reviewers should be answered; and (3) Format: There is 1 table. (4) References: A total of 53 references are cited, including 51 references published in the last 3 years; (5) Self-cited references: There are no self-cited references; and (6) References recommend: The authors have the right to refuse to cite improper references recommended by peer reviewer(s), especially the references published by the peer reviewer(s) themselves. If the authors found the peer reviewer(s) request the authors to cite improper references published by themselves, please send the peer reviewer's ID number to the editorialoffice@wjgnet.com. The Editorial Office will close and remove the peer reviewer from the F6Publishing system immediately. 2 Language evaluation: Classification: Grade C, Grade A, Grade B, and Grade A. 3 Academic norms and rules: No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an invited manuscript. No financial support was obtained for the study. The topic has not previously been published in the WJGS. 5 Issues raised: (1) The column should be minireviews; and (2) The scientific quality can't meet the requirement of WJGS. 6 Recommendation: Transferring to the World Journal of Meta-Analysis.
