2	<p><i>Editorial Office's Comments</i></p> <p>Science Editor: 1 Scientific quality: The manuscript describes a retrospective study of the mortality in patients with lower-third gastric cancer depending on the presence of clinical metastasis in the lymph nodes along the proper hepatic artery (Station 12a) The topic is within the scope of the WJG, but it is more consistent with</p>	[Y]

the scope of the World Journal of Gastrointestinal Oncology. (1) Classification: Grade B and Grade C; (2) Summary of the Peer-Review Report: The authors have presented a well written study which will add to the literature about Station 12a lymph node in gastric cancer. However need to add/ modify few aspects 1. On page 8 under survival significance of No. 12 a lymph node the authors have mentioned the 5 year survival rate for patients with or without 12a metastasis was 39.5% and 5.6% respectively which seems to be contradictory to the general message provided by the manuscript that no. 12a lymph node metastasis carries a poor prognosis. This needs to be checked and corrected. 2. There is no mention about survival analysis with respect to adjuvant treatment wither in the form of adjuvant chemotherapy or radiotherapy. The authors should mention more about adjuvant treatment details when commenting on survival analysis. 3. The authors should comment in the discussion section on whether having no. 12a metastasis changes the management of such cases. Since it is shown that it carries a poor prognosis the authors should comment on the management strategies of the same. 4. The authors should disclose and discuss the preoperative clinical stage based on CT. (3) Format: There are 6 tables and 5 figures; (4) References: A total of 26 references are cited, including 1 references published in the last 3 years; (5) Self-cited references: There are no self-cited references.

2 Language evaluation: Classification: Grade A and Grade A. A language editing certificate was provided. 3

Academic norms and rules: The authors provided the Biostatistics Review Certificate, the Written informed consent, and the Institutional Review Board Approval Form. No academic misconduct was found by the Google/Bing search. 4

Supplementary comments: This is an invited manuscript. The study was supported by grants from National Key Research and Development Program “major chronic non-infectious disease research” (2016YFC1303202), National Key Research and Development Program “precision medicine research” (2017YFC0908304). The topic has not previously been published in the WJG, but similar articles have been published in other journals (DOI:10.1007/s00423-016-1429-9; DOI: 10.3109/03009734.2012.729103; DOI: 10.1371/journal.pone.0118953).

5 Issues raised: (1) Authors don't state on the title page of the manuscript that the guidelines of the STROBE Statement. Please state it; (2) There should be 5 sections of the structured abstract: Background, Aims, Methods, Results, and Conclusion. Please split your Purpose section into the Background and Aims sections. Please add numerical and statistical data to the Results section. (3) The title is too long, and it should be no more than 18 words; please shorten the title. The words such as ‘exploration’, ‘research’, ‘analysis’, ‘observation’, and ‘investigation’ are to be avoided in the title. (4) The first letter of each keyword will be capitalized, and each keyword will be separated by a semicolon. Please, correct. (5) The authors did not
