**Science Editor:** 1 Scientific quality: The manuscript describes a review of the application of adipose-derived stem cells in treating fibrosis. The topic is within the scope of the WJSC. (1) Classification: Grade B and Grade B; (2) Summary of the Peer-Review Report: The manuscript interprets the literature findings adequately and appropriately and highlights key scientific and applied points concisely and clearly. However, some tables and cartoons to simplify and explain the different pathways to approach the therapy of fibrosis should be added; and (3) Format: There is 1 table and 1 figure. (4) References: A total of 65 references are cited, including 51 references published in the last 3 years; (5) Self-cited references: There are no self-cited references; and (6) References recommend: The authors have the right to refuse to cite improper references recommended by peer reviewer(s), especially the references published by the peer reviewer(s) themselves.
