Summary of the Peer-Review Report: The current paper aims to demonstrate the aims to determine trends in non-emergent ED visits for back pain; annual trends in opioid administration for patients presenting to the ED for back pain; and factors associated with receiving an opioid-based medication for non-emergent LBP in the ED. The data is interesting, and it has a relevant rationale. However, the questions raised by the reviewer should be answered; and (3) Format: There is 1 table and 3 figures. (4) References: A total of 34 references are cited, including 5 references published in the last 3 years; (5) Self-cited references: There are no self-cited references; and (6) References recommend: The authors have the right to refuse to cite improper references recommended by peer reviewer(s), especially the references published by the peer reviewer(s) themselves.
