2	<p><i>Editorial Office's Comments</i></p> <p>Science Editor: 1 Scientific quality: The manuscript describes a minireviews of the mood, suicide, and the renin-angiotensin system. The topic is within the scope of the WJP. (1) Classification: Grade B, Grade D and Grade B; (2) Summary of the Peer-Review Report: The review provides a comprehensive description of the researchers' findings of the renin-angiotensin-aldosterone system in mood and suicide. It is a good review article. However, the mood</p>	[Y]

disorders section deals only with depression. Mania does not appear. Schizophrenia should not be included in this section. The suicide section is superficial and lacks analysis; and (3) Format: There are no tables and figures. (4) References: A total of 46 references are cited, including 12 references published in the last 3 years; (5) Self-cited references: There are 4 self-cited references. The self-referencing rates should be less than 10%. Please keep the reasonable self-citations that are closely related to the topic of the manuscript, and remove other improper self-citations. If the authors fail to address the critical issue of self-citation, the editing process of this manuscript will be terminated; and (6) References recommend: The authors have the right to refuse to cite improper references recommended by peer reviewer(s), especially the references published by the peer reviewer(s) themselves. If the authors found the peer reviewer(s) request the authors to cite improper references published by themselves, please send the peer reviewer's ID number to the editorialoffice@wjgnet.com. The Editorial Office will close and remove the peer reviewer from the F6Publishing system immediately. 2 Language evaluation: Classification: Grade A, Grade A and Grade B. 3 Academic norms and rules: No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an invited manuscript. The topic has not previously been published in the WJP. 5 Issues raised: (1) The title is too long, and it should be no more than 18 words; (2) The "Author Contributions"
