(1) Classification: Grade C; (2) Summary of the Peer-Review Report: This review of the role of exercise stress echocardiography is an exhaustive one with some aspects that are too detailed, many figures. The abstract must be improved. The introduction of the review should present more data on the field. Overall, the paper is well written, but needs to be more concentrated (condensed) and organized as it seems too long and the reader may lose the focus when reading. The questions raised by the reviewers should be answered; and (3) Format: There are 19 figures. (4) References: A total of 126 references are cited, including 14 references published in the last 3 years; (5) Self-cited references: There are 14 self-cited references. The self-referencing rates should be less than 10%. Please keep the reasonable self-citations (i.e., those that are most closely related to the topic of the manuscript) and remove all other improper self-citations.
