They should introduce comments on these treatments and comment that there should be multidisciplinary treatment. The questions raised by the reviewers should be answered; and (3) Format: There is 1 table. (4) References: A total of 129 references are cited, including 17 references published in the last 3 years; (5) Self-cited references: There are no self-cited references; and (6) References recommendations: The authors have the right to refuse to cite improper references recommended by the peer reviewer(s), especially references published by the peer reviewer(s) him/herself (themselves).
