(3) Format: There is no figure and table. (4) References: A total of 65 references are cited, including 6 references published in the last 3 years; (5) Self-cited references: There is no self-cited reference. 2. Language evaluation: Classification: Grade A, Grade B. There is no language editing certificate. 3. Academic norms and rules: The Conflict-of-Interest Disclosure Form, the signed Informed Consent Form, the Biostatistics Review Certificate, the Institutional Review Board Approval Form are not provided. No academic misconduct was found by the Google/Bing search. 4. Supplementary comments: This is an invited manuscript. No financial support was obtained for the study. The topic has not previously been published in the WJN. 5. Issues raised: (1) The "Author Contributions" section is missing. Please provide the author contributions; (2) The format of references needed to be revised according to journal's demands. 6. Re-Review: Required. 7. Recommendation: Major revision.
