The topic is within the scope of the WJMA. (1)</p>	[Y]

Classification: Grade B and three Grades C; (2) Summary of the Peer-Review Report: The general methodology on how the authors completed their search is robust and clearly described. The completion of meta-analysis has also been clear, and addresses the pitfalls in their collated data. The questions raised by the reviewers should be answered; (3) Format: There are 3 tables and 3 figures; (4) References: A total of 38 references are cited, including 32 references published in the last 3 years; (5) Self-cited references: There is 1 self-cited reference. The self-referencing rates should be less than 10%. Please keep the reasonable self-citations (i.e. those that are most closely related to the topic of the manuscript) and remove all other improper self-citations. If the authors fail to address the critical issue of self-citation, the editing process of this manuscript will be terminated; and (6) References recommendations: The authors have the right to refuse to cite improper references recommended by the peer reviewer(s), especially references published by the peer reviewer(s) him/herself (themselves). Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout; and (4) The “Article Highlights” section is missing. Please add the “Article Highlights” section at the end of the main text. 6 Recommendation: Conditional acceptance.</p> <p><b>Company Editor-in-Chief:</b> I have reviewed the Peer-Review Report, the full text of the manuscript, and the relevant ethics documents, all of which have met the basic publishing requirements of the World Journal of Meta-Analysis, and the manuscript is conditionally accepted.
