associated with elevated DPP4 levels. The topic is within the scope of the WJG. (1) Classification: Grade A; (2) Summary of the Peer-Review Report: The paper is very interesting, reflect the main hypothesis of the manuscript describing adequately the background, present status, and significance. The reviewer does not make any substantial remarks. Only minor issues are pointed out in the comments in the attached file. (3) Format: There are 4 tables and 2 figures. (4) References: A total of 36 references are cited, including 10 references published in the last 3 years; (5) Self-cited references: There appear to be no self-citations although the citations are not complete 2 Language evaluation: Classification: Grade A. A language editing certificate issued by AJE was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, and the Institutional Review Board Approval Form. Written informed consent was waived. No academic misconduct was found by the Google/Bing search. 4 Supplementary comments: No financial support was obtained for the study. (5) The authors did not provide the approved grant application form(s). (7) PMID and DOI numbers are missing in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout; (8) The "Article Highlights" section is missing. Please add the "Article Highlights" section at the end of the main text (and directly before
