Classification: Grade A and Grade A; (2) Summary of the Peer-Review Report: The study presented in this manuscript is very interesting. Some minor revision points on the possible cause of hyper inflammation in the severe cases of COVID-19 could be included. The questions raised by the reviewers should be answered; (3) Format: There are 7 tables and 2 figures; (4) References: A total of 58 references are cited, including 52 references published in the last 3 years; (5) Self-cited references: There is no self-cited reference. 2 Language evaluation: Classification: Grade A. A language editing certificate issued by AJE was provided. The authors are native English speakers. The manuscript is reviewed by a native English speaker. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the Institutional Review Board Approval Form, the Written informed consent, and the STROBE Statement. No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an invited manuscript. No financial support was obtained for the study. The topic has not previously been published in the WJCCM. 5 Issues raised: (1) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (2) Uniform presentation should be used for figures showing the same or similar contents (using lettered panels); for example: "Figure 1 Pathological changes of atrophic gastritis after treatment. A: ...; B: ...; C: ...; D: ...;

	<p>E: ...; F: ...; G: ..."; (3) PMID and DOI numbers are missing in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout; (4) The "Article Highlights" section is missing. Please add the "Article Highlights" section at the end of the main text; (5) To obey the publication ethics and improve the protection of all patients' rights to privacy, the authors should provide the informed consent form on which the patient's name, address, birthday, address, ward, bed number, hospital number and other private information are obfuscated. 6 Recommendation: Conditional acceptance.</p> <p>Company Editor-in-Chief: I have reviewed the Peer-Review Report, full text of the manuscript, and the relevant ethics documents, all of which have met the basic publishing requirements of the World Journal of Critical Care Medicine, and the manuscript is conditionally accepted.
