This is an interesting paper on clinical and imaging features of Primary Pancreatic Lymphoma. Some sentences need correction. The questions raised by the reviewers should be answered; (3) Format: There are 2 tables and 5 figures; (4) References: A total of 21 references are cited, including 5 references published in the last 3 years; (5) Self-cited references: There is 1 self-cited references. 2 Language evaluation: Classification: Grade A. The authors are native English speakers. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the Institutional Review Board Approval Form. No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an invited manuscript. No financial support was obtained for the study. The topic has not previously been published in the WJCO. 5 Issues raised: (1) The title is too long, and it should be no more than 18 words; (2) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (13)(3) PMID and DOI numbers of some references are missing in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references (PMCID numbers are not required). Please revise throughout; (4) The "Article Highlights" section is missing. Please add the "Article Highlights" section at the end of the main text. 6 Recommendation: Conditional acceptance.
