Science Editor: 1 Scientific quality: The manuscript describes a review of the role of DPP-4 inhibitors in the new era of antidiabetic treatment. The topic is within the scope of the WJD. (1) Classification: Grade C and Grade C; (2) Summary of the Peer-Review Report: The manuscript is likely to be helpful to a wide readership, but several important points are required to be addressed. There are some typos and abbreviations misuse. The author should add some tables and explain some of the content more clearly. The questions raised by the reviewers should be answered; (3) Format: There are no tables and figures; (4) References: A total of 56 references are cited, including 10 references published in the last 3 years; and (5) Self-cited references: There is no self-cited reference. 2 Language evaluation: Classification: Grade B and Grade B. 3 Academic norms and rules: The authors need to provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an invited manuscript. The topic has not previously been published in the WJD. 5 Issues raised: The number of references is less than 100, so the manuscript type needs to be adjusted to "Minireviews". 6 Recommendation: Conditionally accepted.
