Some of the key issues raised by the peer reviewer raised the following queries- 1. Few terminological issues to be fixed 2.The abstract needs amendment 3. Abbreviations need revision. 4. Figures and figure legends require changes. The questions raised by the reviewers should be answered; d. The manuscript has 1 figure and no tables. e. A total of 68 references are cited, including 11 citations published within the last 3 years. f. Self-citations were not found in the manuscript. The self-referencing rate should be less than 10%. g. The authors have the right to refuse to cite improper references recommended by the peer reviewer(s), especially those published by the peer reviewer(s) him/herself (themselves).
