Science Editor: 1 Scientific quality: The manuscript describes a minireview of the diagnosis, treatment and complications of radial head and neck fractures in the paediatric patient. The topic is within the scope of the WJO. (1) Classification: Grade B and Grade C; (2) Summary of the Peer-Review Report: This is not novel topic, but the authors have added the recent evidence on radial head fracture in this review. It is clear for the type of review article. It is easy to be followed. The questions raised by the reviewers should be answered; (3) Format: There is 1 table and 10 figures; (4) References: A total of 75 references are cited, including 23 references published in the last 3 years; (5) Self-cited references: There is 1 self-cited reference. The self-referencing rates should be less than 10%. Please keep the reasonable self-citations (i.e. those that are most closely related to the topic of the manuscript) and remove all other improper self-citations. If the authors fail to address the critical issue of self-citation, the editing process of this manuscript will be terminated; and (6) References recommendations: The authors have the right to refuse to cite improper references recommended by the peer reviewer(s), especially references published by the peer reviewer(s) him/herself (themselves).
