A language editing certificate was not provided. 3 Academic norms and rules: No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an invited manuscript. The study was not supported by any grants. The topic has not previously been published in the WJD. 5 Issues raised: (1) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; and (3) The manuscript format is not correct according to WJD. e.g. Core tip, affiliation are missing. 6 Re-Review: Required. 7 Recommendation: Conditional acceptance.
