	<p><b>Science Editor:</b> 1 Scientific quality: The manuscript describes a minireviews about management of diabetic foot ulcers and challenging points. The topic is within the scope of the WJG. (1) Classification: Grade C; (2) Summary of the Peer-Review Report: The authors addressed the management of diabetic foot ulcers and challenge. This review summarises the current knowledge on the subject; however, it is unfocused and difficult to follow. The authors should add their original point and conclusion. The questions raised by the reviewers should be answered; (3) Format: There are 4 tables and no figures; (4) References: A total of 68 references are cited, including more than 20 references published in the last 3 years; (5) Self-cited references: There are no self-cited references; and (6) References recommend: The authors have the right to refuse to cite improper references recommended by peer reviewer(s), especially the references published by the peer reviewer(s) themselves. If the authors found the peer reviewer(s) request the authors to cite improper references published by themselves, please send the peer reviewer's ID number to the editorialoffice@wjgnet.com.
