### SPECIFIC COMMENTS TO AUTHORS

In the manuscript "Effects of Health Concept-based Care on Mood and Quality of Life in Elderly Patients with Chronic Heart Failure", the authors tried to evaluate the application effect of health concept model-based detailed behavioral care in the nursing care of elderly patients with chronic heart failure. Until now, more and more researchers have devoted themselves to exploring a better nursing intervention model for CHF. However, this study puts forward the view that health concept model-based detailed behavioral care can better promote the rehabilitation of senile CHF patients and improve their CF. Zheng AD et al. performed a single-center retrospective study of 116 elderly patients with congestive heart failure underwent health concept model-based detailed behavioral care and routine detailed behavior nursing intervention. Differences in rehabilitation efficiency, NEs, cardiac function indexes, nutritional status, QoL and nursing satisfaction were observed and compared between groups. Finally, they revealed that detailed behavioral nursing based on the health conceptual model has a high application value in the nursing of elderly patients with CHF. The topic of this work is interesting. Their conclusion might provide additional information for
