Objectives	4	Clearly describe the primary and any secondary objectives of the study, or specific hypotheses being tested.	P6

		a. The number of experimental and control groups.	
		 Any steps taken to minimise the effects of subjective bias when allocating animals to treatment (e.g. randomisation procedure) and when assessing results (e.g. if done, describe who was blinded and when). 	P7-8
		c. The experimental unit (e.g. a single animal, group or cage of animals).	
		A time-line diagram or flow chart can be useful to illustrate how complex study designs were carried out.

		c. Where (e.g. home cage, laboratory, water maze).	
		 d. Why (e.g. rationale for choice of specific anaesthetic, route of administration, drug dose used).

		 b. Provide further relevant information such as the source of animals, international strain nomenclature, genetic modification status (e.g. knock-out or transgenic), genotype, health/immune status, drug or test naïve, previous procedures, etc.

		 Welfare-related assessments and interventions that were carried out prior to, during, or after the experiment.

		 Explain how the number of animals was arrived at. Provide details of any sample size calculation used. 	P7-8
		 c. Indicate the number of independent replications of each experiment, if relevant. 	
Allocating animals to experimental groups	11	 a. Give full details of how animals were allocated to experimental groups, including randomisation or matching if done. 	
		 b. Describe the order in which the animals in the different experimental groups were treated and assessed. 	P7-8
Experimental outcomes	12	Clearly define the primary and secondary experimental outcomes assessed (e.g. cell death, molecular markers, behavioural changes).	P7-8
Statistical methods	13	a. Provide details of the statistical methods used for each analysis.	
		 Specify the unit of analysis for each dataset (e.g. single animal, group of animals, single neuron). 	P9
		 Describe any methods used to assess whether the data met the assumptions of the statistical approach.
