- **Reviewer 1 commented: Robot-assisted surgery represents the progress of science and technology and represents the future direction of human development, but it is not helpful for the prognosis of tumors at present. Moreover, the cost is expensive, large-scale development is suspected of wasting resources, and conditional areas can be carried out according to their actual conditions. The robotic camera holder solves this problem well, which can save cost and carry out minimally invasive surgery.**
