Sample size	10	<ul> <li>Specify the total number of animals used in each experiment, and the number of animals in each experimental group.</li> </ul>	
		<ul> <li>Explain how the number of animals was arrived at. Provide details of any sample size calculation used.</li> </ul>	Page 5
		<ul> <li>Indicate the number of independent replications of each experiment, if relevant.</li> </ul>	
Allocating animals to experimental groups	11	a. Give full details of how animals were allocated to experimental groups, including randomisation or matching if done.	Dogo F
		<ul> <li>b. Describe the order in which the animals in the different experimental groups were treated and assessed.</li> </ul>	Page 5
Experimental outcomes	12	Clearly define the primary and secondary experimental outcomes assessed (e.g. cell death, molecular markers, behavioural changes).	Page 6
