A: Comment: Dear authors, greetings, with interest i read your paper on a fundamental topic demonstrating Low-molecular-weight heparin in patients with preeclampsia. The introduction was well written, methods well described, results well presented and the conclusion supported the aim of the study. However, some old references must be updated.

B: Response:

Thank you for your affirmation of our work and valuable suggestions. We really appreciate your help in improving our manuscript.

We found our references ranged from 2014 to 2022. Reference 4, 15, 24,26,27,32,35 and 39 were from year 2014 to 2016. In these cited references, we found reference 4, 35, and 39 were guidelines. We did not find updated guidelines of these references. Reference 15, 24, 26 and 27 were meta-analyses, of which we cited and summarized in table 1. The purpose of our research was to summarize all the meta-analyses on the topic of heparins application in pregnancy. For the integrity of literature review, these studies were all included. Reference 32 was deleted. A new reference published in 2023 was cited.

We put more focus on the procedure of diagnosing of bleeding and immediate treatment. In addition, due to the fact that our inclusion of patients were all obstetric patients. The treatment for patients in late pregnancy may change immediately according to the patient's clinical symptoms. We focused on the sudden onset of bleeding events in these three patients and summarized the treatment procedure.
