Reviewer suggestions and implementation:

Answer for reviewer's 1 and 2:

We thank the reviewer for their valuable comments that certainly added to the value of our article.

1. The reviewers have correctly pointed out that the article does not provide any idea about the number of patients with celiac disease; rather it only gives the sero-prevalance of the disease. We agree with the reviewer in this regard, the aim of the article is in fact is to study the sero-prevalence of celiac disease and we do not know the phenotypic characteristics of these individuals. Given the high specificity of these serological markers we would postulate that the true prevalence would be approximate to the sero-prevalence, however this is an assumption that would require further validation in a separate study. We have, however, provided the exact number of patients and their respective percentages within the articles.
2. The reviewer suggested applying power analysis and adding the results. Power analysis has been added and the following sentence "Based on a general prevalence of 1% in various populations and an estimated prevalence of 3% in the Saudi population, we determined the sample size at *P-value* (alpha) = 0.05 and power = 0.70 and a standard deviation of 0.25, the estimated sample size would be 965 individuals". This has been incorporated in the statistical analysis segment.
3. The reviewer asked to check the reference and their typesetting. We've incorporated the suggestions and now the references are left indented and in correct format.
