Even if the authors believed that this is not the main subject of the paper and the text might indirectly suggest to the readers that they were family liver transplantations the reason for the transplantations provided in the paper.

We understand the objection and have included the information on the indications for the liver transplantation in the additional **(Material & Methods) section: Recipient indications for liver transplantations** enclosing them in an additional table-1. Consequently we have renumbered the all other tables accordingly

I am interested about the cases after 2007, what did you chose for recent liver transplant procedures?

Following the discontinuation of the adult LDLT program at the University Hospital Essen in 2008 we still have followed the individualized MHV management concept using our MHV-volume/anatomy-safety characteristics to prevent liver failure in extended right graft donors. However, the application of our policy was limited by a small set of patients mainly involving full left graft- or non-MHV containing right graft LDLT at the Universities of Kiel and Tuebingen.

We hope that the manuscript in its current form will satisfactorily meet the reviewer expectations and can make a valuable contribution to the field of living donor liver transplantation.

We look forward to a favourable response, and again very much appreciate the considerable support given to us by the excellent reviewer comments intended to make this paper compatible with the exceptional quality and standing of your prestigious Journal.
