- (2) The embryology and the development features of the patellar bone should be written at introduction part .
Thank you very much for that suggestion . We have included developmental features and its relation to relative resistance of patella against affection of bone tumours in the introduction also.
- (3) The rarity of Ewing sarcoma at patella and the other neoplasm who were prone to involve patella bone should be written at introduction part .
Thank you very much for that suggestion. We have highlighted the rarity of neoplasm in and common bone tumours that affect patella in the introduction part.
- (4) Regarding FNAC we also feel now that core biopsy at that time was much more effective. But patella being a superficial bone we opted open biopsy.
- (5) Regarding the surgery we have given a detailed description regarding position , anaesthesia, incision, technique of the whole procedure.
- (6) Regarding the various tumours affecting patella has been included in the introduction also.
- (7) We have not given much stress to genetic and histopathologic features in discussion because our main aim was to discuss regarding the rarity of ewing sarcoma of patella and its treatment using tendoachilles graft.

- (8) We have given reference regarding the two cases of Ewing sarcoma of patella in the literature.
- (9) Regarding the magnification of histopathologic picture it is H&E X 400. It is given in the figure 2A legend.
