I wondered if the questionnaire not used for Dietary details was validated.</p>	<p>(a) The alcohol consumption pattern of drinkers (amount, type and frequency) was noted and converted in terms of average alcohol consumed in grams per day (A detailed description regarding the assessment of alcohol consumption has been added in the methodology- page no:8; line 5-10)</p> <p>(b) Physical activity was measured in terms of MET levels. For walking, moderate and vigorous intensity activities MET was taken as 3.3, 4.0 and 8.0 respectively. The activities were measured separately (MET level x minutes of activity/ day x days per week) and expressed as total MET min/ week (A detailed description regarding the assessment of physical activity has been added in methodology- page no: 8; line 5-11)</p> <p>(c) The alcohol consumption among study participants was measured and classified as per the WHO STEPS questionnaire.</p> <p>(d) The physical activity was measured using international physical activity questionnaire- short version.</p> <p>(e) Dietary details were measured using Food Frequency Questionnaire which was developed, validated and pre-tested before it was used for the study.
