Rdiologic images should be demonstrated. Therefore, It schould be published in Presentation wit radiologic images.

Thank you for your comments. Unfortunately, the quality of the ultrasound images lacked the standard calibre of quality necessary for your esteemed journal. We feel that the addition of radiographic would not be a valuable addition to the case. Abdominal aortic and mycotic aneurysms have been well described in other literature and such images are not particularly unique or interesting. Understanding the case is not contingent on viewing the images. However, if you still feel that the images are essential, we will endeavor to provide them.
