Dear Lena,

Kindly issue a new cost center for the attached research agreement signed with the Lebanese National Council for Scientific Research (CNRS). The project is entitled: "**Potential role of HLA and KIR as Correlates of Protection among Hepatitis B Virus (HBV) Vaccinated and Non-Vaccinated Subjects**" and will be conducted by Dr. Nada Melhem from the Faculty of Health Sciences.

The project is for a period of two years from December 1<sup>st</sup>, 2009 until December 1<sup>st</sup>, 2011, with a total budget of L.L. 24,000,000. The budget for the first year is L.L. 12,000,000 divided as per the attached budget breakdown. Please note that Project Investigator cannot spend more than L.L. 12,000,000 in the first year.

**Mode of Payment & Reporting:** There will be three Payments:

- 40% of the total budget upon signature of this Agreement.
- 35% of the total budget will be paid upon receipt and approval of the Progress Narrative and Financial reports at the end of the first year \*.
- 25% of the total budget will be paid upon receipt and approval of the Final Narrative and Financial reports upon the completion of work.

**\*Note to PIs:** To encourage the continuity of the project Principal Investigators are encouraged to submit progress narrative reports on December 1<sup>st</sup>, 2010 or even one month before.
