- There must be a signed agreement between the Grant recipient and ECCO (to be sent to you in due course from the ECCO Office)
- When presenting or publishing results of the Grant project, the name and logo of ECCO will be presented on all printed matter or slide presentations by way of acknowledgement to ECCO.
- If the full paper is not published in *JCC* or *Gut*, then a synopsis of the paper from the work supported by the Grant should be submitted to *JCC* for publication as a "selected summary" of ECCO publications.

Can you please confirm acceptance and send details of the account to which the money will be paid to the ECCO Office (m.cunockova@ecco-ibd.eu). A contract will be drawn up that will need to be signed by the Head of Department at the Grant candidates' institute and the Grant candidate.
