3. The expenditure involved is debited to

Grant – in –aid for the year 2013-2014 (Plan Expenditure General) – Rs.10,00,000/-

This release is made under Science & Engineering.

4. The sanction has been issued with the approval of competent authority under delegated powers and vide Diary No. SERB/F/ 0991 / 2013-14 dated 23.05.2013

5. Sanction of the grant is subject to the conditions as detailed in Annexure-1

6. Overhead expenses are meant for the host Institute towards the cost for providing infrastructural facilities and general administrative support etc. including benefits to the staff employed in the project.

7. While providing operational flexibility among various subheads under head General -A , it should be ensure that not more than Rs.1.5 lakh each should be spent for travel and contingency.

8. The total release amount of **Rs.10,00,000/- (Rs. Ten Lakhs Only)** will be drawn by the Drawing & Disbursing Officer of the SERB and will be disbursed by means of cheque/DD favoring **The Registrar, Lucknow University , C-2201, Indira Nagar, Lucknow-226016, U P** and will be sent to **The Registrar, Lucknow University , C-2201, Indira Nagar, Lucknow-226016, U P**.

9. As per Rule 211 GFRs, the accounts of the project shall be open to inspection by the sanctioning authority / audit whenever the Institute is called upon to do so.

10. The Institute will furnish to SERB, utilization certificate and audited statement of accounts pertaining to the grant immediately after the end of each financial year.


11. The manpower sanctioned in the project, if any is co terminus with the duration of the project and SERB will have no liability to meet the fellowship etc. beyond the duration of the project.

12. The Institute will maintain separate audited accounts for the project. If it is found expedient to keep a part or whole of the grant in a bank account earning interest, the interest earned should be reported to SERB. The interest thus earned will be treated as a credit to the Institute to be adjusted towards further instalment of the grant.


13. The sanction equipments would be procured, as per GFR and its disposal would be done with prior approval of SERB.
