Reviewer #1:

Point 1. *Multidrug resistant organisms and emergence of new strains of Clostridium difficile are becoming increasingly significant with solid organ transplants. Authors should comment in further in more detail on this emerging issue. Authors should comment on emerging modalities of treatment, including fecal microbial transplant.*

Response: We agree with the Reviewer that multidrug resistant organisms and emergence of new strains of *Clostridium difficile* are becoming increasingly significant with solid organ transplants. However, to date there are insufficient data describing the new strains of *Clostridium difficile* or emerging modalities of treatment, including microbial faecal transplant in liver transplant patients who have received SID

Reviewer #2:

Point 1. *The Authors should emphasize the clinical importance of their comparative analyses and better explain the sentence “Further randomized controlled studies evaluating SID strategies are warranted, preferably analyzing non-absorbable antimicrobials or non-antibiotic products which carry a theoretical lower ecological deleterious effect”.*

Response: Following the Reviewer's suggestions, we have modified the manuscript.

Point 2. *Tables should be indicated as 1, 2, 3 and 4.*

Response: We have changed the numbering of the tables.
