Comments:

This is a well-written paper to analyze the factors affecting the QOL after gastrectomy using PGSAS-45. The result that the symptom severity affected QOL most was natural but very impressive. I have some minor comments: In Table 2, Item 29 is followed by (Ans. Q21). Similarly, Item 30 and 31 are followed by Question 21, Item 32 is followed by (Ans. Q24)... In Acknowledgements, some doctors' names are written conversely; Drs. Inagawa Satoshi, Ueda Shugo, Uesono Yoshikazu, and Shibata Chikashi.
