BHIVA Research Awards 2009: Prevalence of, and factors associated with significant liver disease in HIV-infected patients exposed to didanosine and development of a screening strategy using transient elastography to identify sub-clinical disease

The BHIVA Education and Research Subcommittee met on 22 September 2009 under the leadership of an independent Chair, Professor DJ Jeffries, and considered the applications for the BHIVA Research Awards 2009.

You may have been concerned that you had not yet heard from BHIVA sooner; however there have been some queries to resolve regarding certain applications and the Subcommittee has given these issues very careful consideration. I am pleased therefore now to be able to let you have the results of this year's BHIVA Research Awards.

This year we received 20 applications and I can tell you that the standard was extremely high. As you know, the upper award limit is £10,000 per applicant, and this year the aggregate value of awards will be over £40,000. Details of the winners will be posted on the BHIVA website at www.bhiva.org.

We are pleased to confirm that your application for funding the above project has been successful and an award of £7800 has been granted. Many congratulations on behalf of the Subcommittee.

Following correspondence with the Secretariat, we note that your project is now due to commence in April 2010, with a completion date of April 2011. Please see the conditions of the BHIVA Research Awards and a list of information required by the Association:
