Comment #1 from U1: Please revise and perfect your manuscript according to peer-reviewer's comments

- 1) We have reformatted the first 4 pages of the manuscript to match those provided in the "Format for Manuscript Revision: Minireviews." These include changing the name of journal, adding ESPS manuscript number and manuscript type, editing the conflict-of-interest statement, adding the Open-Access statement, editing the abstract, adding the copyright statement, and editing the citation for the article.

Comment #2 from U2: As review, you just need to write a summary here, just one paragraph, not need the second headline.

- 2) We have edited the format of the abstract to be only 1 paragraph with a total word count of 253 as requested. We also eliminated the word count displayed under the abstract as requested.

Comment #3: Audio Core Tip

Comment #4: Delete title prior to starting Introduction

- 4) We have deleted the title of the paper above the introduction on page 5 of the paper.

Comment #5 from U3: Please check that there are no repeated references. Please add PubMed citation numbers and DOI citations to the reference list and list all authors throughout.

- 5) We have reviewed all citations and did not come across any duplicate citations. The only potential duplicate had the same author (citations 8 and 9 – Jelliffe RW), but are not the same citation as indicated by different PMIDs and DOIs.
- 6) All citations now include the PMID and DOI numbers requested with the exception of:
 - a. Citation 4: This is a section from a pharmacotherapy book and therefore does not have a PMID/DOI number
 - b. Citation 10: PMID is included but there is no DOI number for it to our knowledge.
 - c. Citation 13: PMID is included but there is no DOI number for it to our knowledge.

- d. Citation 14: This is an online document from the US FDA and therefore does not contain a PMID or DOI number.
 - e. Citation 20: PMID is included but there is no DOI number for it to our knowledge.
 - f. Citation 22: PMID is included but there is no DOI number for it to our knowledge.
