First-person pronouns (<i>e.g.</i>, 'I', 'we') are used appropriately to clearly indicate the work performed by the author(s). 25	The 'COMMENTS' section provides comments for original articles in accordance with the specified format.	[N]

26	<p>The 'REFERENCES' section lists the references in the Vancouver style. This style uses Arabic numeral in-text citations based on the order of the first appearance of a source in the text. For citations where the author's name is indicated in the text, a superscript number should be placed following the name (<i>i.e.</i>, "Pang <i>et al</i>"). For citations where no author is indicated, a superscript number should be placed at the end of the sentence. Respective examples are: "Ma ^[1] reported", "Pan <i>et al</i> ^[2-5] indicated" ; "PCR has a high sensitivity ^[6,9]." No superscript numbers are used when the reference number is described in the text; for example, "The experimental method used has been described in reference [8]." The style of reference citations in tables is the same as that in the text (<i>e.g.</i>, Pan <i>et al</i> ^[2-5], please see reference [8]).</p>	[Y]
